VOTING

If you own MBIA stock at the close of business on March 10, 2010, you are entitled to vote. You have one vote for each share of MBIA common stock you own.

MBIA Inc. has adopted Notice and Access, the Securities and Exchange Commission rule, which allows companies to furnish proxy materials to shareholders over the Internet. Notice and Access expedites shareholders' receipt of proxy materials, while lowering the cost and reducing the environmental impact of MBIA Inc.'s annual meeting.

To vote, follow the instructions on your notice, which you will receive by mail or email, or on your proxy card. These instructions indicate that to vote electronically you should go to www.proxyvote.com, to vote by phone, call 1-800-690-6903, or to vote by mail, use your proxy card. You also have the option of voting in person by submitting your proxy at the annual meeting.

A printed copy of the proxy materials can be obtained free of charge by contacting www.proxyvote.com, calling 1-800-579-1639 or emailing sendmaterial@proxyvote.com. You may also request the materials from Investor Relations at MBIA Inc., 113 King Street, Armonk, NY 10504.

Please note that the recently enacted NYSE Rule 452 no longer allows brokerage firms to vote your shares on proposal one (Election of Directors) unless specifically instructed. Therefore, it is important that you vote your shares for all proposals including the election of directors, or contact your broker to provide instructions.
